Please bring ALL tax records, including, but not limited to, picture IDs, W-2 forms, 1099s, Social Security Cards (or ITIN); a voided check for refunds; medical expenses.; Employer ID (EIN) or SSN of all childcare providers; and proof of medical health insurance (on W2 or 1095-A). As a cost saving measure, the North Carolina Department of Revenue no longer provides North Carolina income tax forms and instruction booklets to public libraries. Additionally, the IRS provides minimal federal tax forms and publications to public libraries.
