SUMMARY OF INFORMATION:

In January 2017, the Forsyth County Chief Financial Officer will sell two-thirds bonds to provide funding for three Capital Maintenance/Repair Plans. The bonds are a part of the bi-annual issuance of 2/3rds capacity to provide a consistent funding stream to meet the capital repair and maintenance needs for the Winston-Salem/Forsyth County Schools, Forsyth Technical Community College, Parks & Recreation, and general County projects.

The purpose of this item is to establish the three Capital Projects Ordinances (CPO's) in order for the funds to be expended on projects identified under the various CPO's.
