**WHEREAS** bid invitations for seven mid-size sedans to be utilized by the Forsyth County General Services Department were issued directly to a total of 17 qualified businesses, as well as advertised on the City-County Purchasing website and the Winston-Salem Journal;

**WHEREAS** bids were received and publicly opened by the City/County Purchasing Department at 1:00 PM on Tuesday, November 12, 2019, for the purchase of seven mid-size sedans per bid specifications, and the following bids were received:

**WHEREAS** the lowest bid is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers discount prices to public agencies, compliant with N.C.G.S. 143-129(e)(3); and

**WHEREAS** the County Manager, the County General Services Director, and the City/County Purchasing Director recommend that a contract for the purchase of seven 2020 Chevrolet Malibu Sedans per bid specifications in the amount of \$16,207 each be awarded to Performance Automotive Group, Inc., for a total contract amount of \$113,449;

**NOW, THEREFORE, BE IT RESOLVED**, by the Forsyth County Board of Commissioners, that a contract for the purchase of seven 2020 Chevrolet Malibu sedans per bid specifications is hereby awarded to Capital Chevrolet, Inc., in the total amount of \$113,449 and that all other bids are hereby rejected, and that the County Manager and Clerk to the Board are hereby authorized to execute a contract with Capital Chevrolet, Inc., for the purchase of such vehicles in a total amount of \$113,449, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
