**RESOLUTION CHANGING THE NAME OF THE  
FORSYTH COUNTY CONSOLIDATED HUMAN SERVICES BOARD  
TO THE  
FORSYTH COUNTY HEALTH AND HUMAN SERVICES BOARD**

**WHEREAS**, N.C.G.S. 153A-77 authorizes counties to consolidate departments into a Consolidated Human Services Agency to promote efficiency and effectiveness and to appoint a Consolidated Human Services Board with authority to exercise the powers conferred by law; and


**WHEREAS**, on June 21, 2018 Forsyth County Commissioners conducted a public hearing on consolidation of human services with no one from the public speaking against or in favor of the proposal; and

**WHEREAS**, on June 21, 2018, the Forsyth County Board of Commissioners unanimously voted to establish a Forsyth County Consolidated Human Services Agency; and

**WHEREAS**, members of the Consolidated Human Services Board have determined that after a year of operating as a unified board, it is appropriate to shift from Consolidated Human Services Board to being the Forsyth County Health and Human Services Board.

**NOW THEREFORE BE IT RESOLVED** that the Forsyth County Consolidated Human Services Board requests that the Board of County Commissioners now refer to the Consolidated Human Services Board as the Forsyth County Health and Human Services Board.
