**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:**

**SUMMARY OF INFORMATION:**

On December 31, 2019, the Forsyth County Sheriff's Office was notified that the agency is eligible to accept \$171,913 in 2019 State Criminal Alien Assistance Program (SCAAP) funds from the U.S. Department of Justice, Bureau of Justice.

As per the Department of Justice Reauthorization Act of 2005 (Pub. L. 109-162, Title XI), SCAAP funds must be used for correctional purposes only and as per a list of allowable uses. The Sheriff's Office maintains, in coordination with Budget & Management, documentation showing past use of funds and projected use of future funds.

Since the original award in 2010, including the latest eligible amount, a total of \$1,048,473 has been received and an estimated \$495,048.01 will be expended through June 30, 2020. A history of this program is shown in the table below.
