Meeting Called to Order

A special meeting of the Forsyth County Board of Elections was called to order in the second floor Board room on Friday, November 12, 2021 at 10:00 a.m., Secretary Jourdan presiding pending Chairperson Durrah's arrival.

Meeting Called to Order

Secretary Jourdan called the meeting to order at 10:01 a.m.

Recount for Village of Clemmons Council Election

Director Tsujii addressed the public in attendance to clarify that the recount was discretionary based upon guidance received by the State Board of Elections prior to the meeting. He recapped the process of the final determination that the requested recount filed by Pamela (PJ) Lofland was not in fact mandatory as it did not meet the required threshold; however in an effort to provide transparency the public, the Forsyth County Board of Elections would proceed with a discretionary recount. The recount began at 10:07 a.m.

Director Tsujii provided the zero reports for each of the high-speed tabulators being used for the Village of Clemmons jurisdiction recount to the Board for review and signature. The recount included Precinct 51 – Clemmons First Baptist Church, Precinct 52 – Clemmons Presbyterian Church, Precinct 54 – Clemmons Civic Center, Precinct 55 – Holy Family Catholic Church, Precinct 72 – Southwest Elementary School, 8 - Absentee By-Mail ballots, 6 – Provisional ballots, 29 – One-Stop Early Voting ballots and 94 Write-In ballots..

Chairperson Durrah arrived at 11:42 a.m., recount was in process.

Director Tsujii presented to the Board the tabulation reports for review and signature stating that the Absentee By-Mail ballots, Provisional ballots, and One-Stop Early Voting ballots matched the Canvass tabulation report with no discrepancies. The tabulation report for Precinct 51 – Clemmons First Baptist, Precinct 52 – Clemmons Presbyterian, Precinct 54 – Clemmons Civic Center, and Precinct 55 – Holy Family Catholic Church was reported and had no discrepancies., The tabulation report for Precinct 72 – Southwest Elementary was provided and reported one discrepancy for Bradley Taylor compared to the Canvass report.

Director Tsujii announced the results of the recount to the Board and public in attendance: Michelle Barson – 1,148 votes, Mary L. Cameron – 1,069 votes, Bradley Taylor – 1,013 votes, and Pamela (PJ) Lofland – 982 votes and 94 Write-In votes. There were no changes in the results for the Village of Clemmons Council Election.

Adjournment

Member Doomy moved to conclude the recount for the Village of Clemmons Council; Chairperson Durrah seconded; **Motion carried unanimously**. Meeting adjourned at 1:00 p.m.
